The Garfield County Board of Commissioners met Tuesday, April 28, 2026, at 1:30 p.m. in the Commissioners Room at the Garfield County Courthouse in Burwell, Nebraska pursuant to public notice posted in three public places. Chairman Hurlburt called the meeting to order at 1:30 p.m. with the following present: Commissioners, Hurlburt, Zulkoski, and Krause.

Motion made by Zulkoski to approve the agenda, second by Krause. Roll call vote: Aye, all; Nay, none.

Motion made by Krause to approve & adopt minutes of last County Commissioners meeting held April 14, 2026, second by Zulkoski. Roll call vote: Aye, all; Nay, none.

Chairman Hurlburt directed the meeting to unfinished business; Installation of auto gates on 836<sup>th</sup> Road by Lin and Brett Gumb.
